H.E. Ambassador Ms. Antje Leendertse, Permanent Representative of the Permanent Mission of Germany to the United Nations since September 2021. Prior to this appointment and since 2019, Ambassador Leendertse served as the State Secretary of the Federal Foreign Office. She also served as the Political Director in the Federal Foreign Office Berlin (2018-2019) and Permanent Representative of the Federal Republic of Germany to the Office of the United Nations and to the other International Organizations in Geneva (2017-2018). Before these appointments she served, inter alia, as the Head of the Task Force for the 2016 OSCE Chairmanship, as Federal Government Commissioner for Disarmament and Arms Control, as Director for Eastern Europe, the Caucasus and Central

Asia as well as Head of Division for the Western Balkans. She received a Master's degree in medieval and modern history, Romance languages, economics and philosophy from the University of Cologne in 1989. Ambassador Leendertse is married with one daughter.



H.E. Ambassador Dr. Michal Mlynar, Permanent Representative of the Permanent Mission of Slovakia to the United Nations. Dr. Mlynár, presented his credentials to UN Secretary-General António Guterres on August 17, 2017. Prior to his appointment, Dr. Mlynár was Slovakia's Director-General for International Organizations, Development Cooperation and Humanitarian Aid between 2015 and 2017. From 2012 to 2015, he was Ambassador to Kenya and to the United Nations agencies in Nairobi. Dr. Mlynár held several positions from 2010 until 2011, including Head of the Project Team for Security Sector Reform, Deputy Chef de Cabinet in the Office of the Minister, and Head of the Unit for Coordination of Candidatures and Cross-Cutting United Nations activities. Between 2004 and 2009, Dr. Mlynár was Deputy

Permanent Representative to the United Nations in New York, and his delegation's political coordinator on the Security Council from 2006 to 2007. He was also Deputy Chef de Cabinet and Parliamentary Secretary to the Minister between 2002 and 2004. She has long-standing research and policy experience in human development and infrastructure related sectors. Of these, urban development, water and sanitation, demography, health, social protection and social development, stand out. Mayor Reker started school at the Protestant Primary School in Cologne-Bickendorf. She graduated from the Liebfrauenschule in Cologne-Lindenthal with *Abitur* (general university entrance qualification) in 1975 and then went on to study law between 1976 and 1986. From 1990 until 1992 she did a Legal Clerkship at the District Court in Münster and worked for the Professional Association of Wood and Metal Trades (BGHM) in Bielefeld. She then worked as a Legal counsel for the State Association of Guild Health Insurance Funds, Münster

until the year 2000. In 1996 she also gained admission as a lawyer to the District Court in Münster. From 2000 until 2010 she was Deputy Mayor for Social Affairs, Health and Consumer Protection in the city of Gelsenkirchen before returning to her hometown in 2010, where she also became Deputy Mayor for Social Affairs, Integration and Environment in the city of Cologne. In 2015 Henriette Reker was elected to be the first female Mayor of the City of Cologne. She was re-elected in 2020. In her limited spare time, Ms. Reker likes to cook. She also enjoys taking part in Cologne's myriad cultural offerings, in particular attending classical music performances and viewing art exhibitions at Cologne's many galleries. Many of Cologne's cultural events are a fixed part of her calendar, also the annual Rose Monday Parade and the many seasonal Karneval gatherings. Mayor Reker was born in 1956 in Cologne and she is married.
