H.E. Ambassador Dr. Michal Mlynar, Permanent Representative of the Permanent Mission of Slovakia to the United Nations. Henk Ovink, Special Envoy for International Water Affairs, Kingdom of The Netherlands, Sherpa for the UN 2023 Water Conference. Henk Ovink was appointed in 2015 by the Dutch Cabinet as the first Special Envoy for International Water Affairs. As the Ambassador for Water, he is responsible for advocating water awareness around the world, building institutional capacity and coalitions amongst governments, multilateral organizations, private sector and NGO's, and initiating innovate approaches to address the world's stressing needs on water. "Worldwide, water is the number one global risk, the connecting challenge across the 2030 Agenda for Sustainable Development and our best opportunity for inclusive and comprehensive action!" Ovink is also Sherpa for the UN 2023 Water Conference and leads the government of the Netherlands as co-host of the conference. Henk Ovink served on President Obama's Hurricane Sandy Rebuilding Task Force where he led the long-term innovation, resilience, and rebuilding efforts. He developed and led the 'Rebuild by Design' competition and initiated the National Disaster Resilience Competition. Before joining the Task Force Ovink was both Acting Director General of Spatial Planning and Water Affairs and Director National Spatial Planning for the

Netherlands. Henk teaches at Harvard GSD, the London School of Economics and the University of Groningen. His book - written together with Jelte Boeijenga - "Too Big. Rebuild by Design: A Transformative Approach to Climate Change" explores his climate and water work for the Obama Administration. In January 2018 Henk Ovink was awarded for his 'transformative global water work' an honorary membership from the Royal Institute of Engineers of the Netherlands. At the World Urban Forum in February 2020 Henk was awarded the IHS Urban Professional Award 2020.



Sulton Rahimzoda, Special Envoy of the President of the Republic of Tajikistan to the High-Level Panel on Water and Climate Leaders. Sulton Rahimzoda is a Hydraulic Engineer and has experience working with issues of safety of dams and other hydraulic structures such as planning and managing the water reservoir, investigation of sedimentation processes, water resources management, including at the transbopudary level, hydropower development and climate change issues. Mr. Rahimzoda chaired the Executive Committee of the International Fund for saving the Aral Sea (IFAS) dealing with the mitigation of the Aral Sea disaster in five Central Asian countries in 2005-2008. Thus he knows well the water, energy and environmental problems of Central Asia region. Mr. Rahimzoda has also experience working with plans and policies for water management, environment and disaster risk reduction in various positions in the government of Tajikistan. In 2010- 2013, Mr. Rahimzoda worked as First Deputy Minister of Land Reclamation and Water Resources and from November 2013 to May 2019 at the position of First Deputy Minister of Energy and Wa- ter Resources of the Republic of Tajikistan. In 2013-2019, he was Member of the Interstate Comis- sion for Water Coordination of the

Central Asia, representing Tajikistan. From May 2019 to Sep- tember 2020, he worked as the Ambassador Extraordinary and Plenipotentiary of the Republic of Tajikistan to the Republic of India. Mr. Rahimzoda led the process of reforming the water sector in Tajikistan starting from 2016 to 2019. During his tenure as First Deputy Minister of Energy and Water Resources, the Water Sector Reform Program of Tajikistan for the period 2016-2025, the Law on Drinking Water and Sanitation, the draft Water Code in new edition, the draft Law on Wa- ter Users Asossiations, the draft National Water Strategy and many other sectoral programs and documents have been developed and approved by the Government and the Parliament of Tajikis- tan.Mr. Rahimzoda is also very active in promoting and advancing of water issues at the regional and international levels. He was a member of the International Steering Committee of the 1st Asi- a-Pacific Water Summit held in 2007 in Beppu, Japan and Co-Chairs of the International Steering Committees of the HighLevel International Conference on Water Cooperation, held on 20-21 Au- gust 2013 in Dushanbe, the High Level International Conference on Implementation of the Interna- tional Decade of Action "Water for Life", 2005-2015 held on 9-11 June 2015 in Dushanbe, Tajikis- tan and, the HighLevel International Conference on Implementation of the International Decade of Action "Water for Sustainable Development", 2008-2018 held on 20-22 June 2018 in Dushanbe, Tajikistan. Since January 2021, Mr. Rahimzoda is Co-Chair of the International Advisory Committee of the Dushanbe Water Process, dealing with facilittaion of the preparatory processess of the Dushanbe Water Conferences on International Deacde of Action "Water for Sustainable Develo- pemnt", 2018-2028. He was a Special Envoy of the President of the Republic of Tajikistan to the High -Level Panel on Water Resources, which functioned from April 2016 to 14 March 2018. Currently, he is Special Envoy of the President of the Republic of Tajikistan to the High -Level Panel on Water and Climate Leaders. Sulton Rahimzoda is author of a number of publications on various aspects of water resources management in Tajikistan and Central Asia. In September 2020, Sulton Rahimzoda for the second time was appointed as a Chairman of the Executive Committee of the International Fund for Saving the Aral Sea.

He is the founder of Climate CARO, motivating universities to train M.S. students for senior business positions as Climate Change Risk and Opportunity Officers. He spoke on a panel at the 2015 Paris UN Climate Conference and attended the 2009 Copenhagen Climate Conference. Jan

was a leader and innovator in quantitative finance and risk management at major financial institutions for many years. In his earlier career as a physicist, Jan was Directeur de Recherche at the Centre de Physique Théorique (CNRS, Marseille, France).



Helen Holden Slottje, Esq., Slottje Law, and the 2014 Goldman Environmental Prize Winner for North America. Helen was awarded the Goldman Environmental Prize for her pioneering legal work that successfully defended New York communities from environmentally destructive fracking (high-impact industrialized extraction of natural gas from solid rock). In the face of a state statute that prohibited local regulation of the oil and gas industry, and a state-wide regulatory agency with the mission of promoting the oil and gas industry, Helen was undaunted. She developed an innovative strategy that employed constitutionally protected local land use planning powers to prohibit fracking. With the help of her husband David, Helen worked tirelessly to ensure that communities could refuse to host fossil fuel extraction through enacting local laws. With the Slottjes' help, over 150 communities across the state organized and passed local measures to

stop fracking. These local laws faced heavy opposition and ultimately litigation from powerful entrenched interests that sought to have the laws declared unenforceable. In a major victory for the people, the New York courts upheld these local fracking bans. Ultimately this community-based resistance led to an unprecedented state-wide ban on fracking, a true David and Goliath victory. Helen continues to bring her unique insights and legal advice to purpose driven businesses that seek to incorporate sustainable development goals into their culture. Helen is an Honorary Advisor of the NGOCSD-NY and as a member of the Urban Cluster.
